Opening: Chairman Gary Richter called the meeting to order and gave the invocation.

Appointment of additional members to the FBO RFP Selection Subcommittee:

Paula Baucum moved to appoint Michael Scott (Assistant Manager, City of Waxahachie), Don Hastings (Manager, City of Midlothian) and Ray Brindle (Tenant Liaison, Mid-Way Airport) as additional members to the FBO RFP Selection Subcommittee; second by George Kent. All Ayes.

Gary Richter said that Stephen Dueboay with the City of Midlothian will also be present at the meetings to make sure that the Subcommittee does everything correctly while moving through the process of selecting the FBO.

Opening of the Fixed Base Operator proposals: Stephen Dueboay explained the RFP process to the Subcommittee. Andy Biery said that he spoke with the Airport Attorney, and all of the meetings regarding this topic will be posted as open meetings, and the items that are specific to the negotiation process will be held in Executive Sessions. Any general discussion that is not pointed, or conflict with our interest can be discussed in open public session. Stephen Dueboay explained that all of this is to protect the interest of the Airport and Cities. Stephen said that there could be information in the proposals that would be proprietary, which could give one of the other parties advantage in the negotiations, if found out.

Stephen Dueboay opened the three proposals received. The proposals were from Southern Star Aviation in Midlothian, Texas, Panda Aviation in Dallas, Texas, and Airport Business Solutions in Denver, Colorado.
