Staff is working with KSA and TxDOT reviewing the details on what we will be able to use this on and will report back to the Airport Board in the near future.

January 19th – Meeting with Airport EDC Committee and joint groups from both Cities by Zoom. Heard a presentation from a (MRO) Maintenance Repair and Overhaul group who is considering relocate to Mid-Way Regional Airport. Committee had decided to follow up with our two Cities EDC Directors on a site visit and tour of their company.

January 26th – 1pm Zoom meeting with Regional Public EV infrastructure Project Working Group to collaborate and discuss public electric vehicle charging infrastructure projects across North Texas and plan for any upcoming corresponding funding opportunities.

January 31st – Both Cities EDC Directors Warren Ketteman (Waxahachie) and Kyle Kinateder (Midlothian) toured the MRO group we had our presentation from. Very good tour and highly impressive.
